The Mali irrigation project is a continuation of START's partnership with the University of Ghana and ICRISAT Mali to advance understanding of barriers to and enablers of climate change adaptation in northern Ghana and southern Mali, through the lenses of governance, social differentiated vulnerabilities and ecosystem services. The research focuses on agricultural intensification processes that can create a more enabling environment for better adapting to climate change through the factors that drive intensification, such as access to credit, services, inputs, markets, equipment, infrastructure, and enabling policies.
